

FAM CAMP PATRONS

1. Registration by eligible patrons will be done with the Fam Camp Office and based on availability. Sites will be assigned according to rig size & amps.
2. No advance reservation practiced.
3. Each patron will be issued a 5x9 in card showing site number and date of departure.
4. Patrons will receive rules, regulations, and combination to bath house & laundry room.
5. If patrons wish to extend their stay, they must do so by 1700 the day before they are due to be out. Checkout is noon daily.
6. The maximum length of stay is 14 days during peak season (1 April - 30 September)

TORNADO WATCH

1. Secure any personal loose items outside the RV.
2. Monitor the local radio and TV.

TORNADO WARNING

1. Confirmed sightings and movements will be broadcast.
2. A steady 3 - 5 minute tone on the base siren indicates a tornado has been sighted and Tinker AFB appears to be in its path.
3. If either the base siren or a loud roar is heard, take cover in the storm shelter.
 Pets are allowed in the shelter.
*The Fam Camp tornado shelter is in the NE corner of the camp on the right side of the bathhouse.
 Base sirens are tested Saturdays at Noon.*

SUPERVISION & CARE OF PETS

1. Pets must be on a leash and kept inside from 2200 - 0600.
2. Pet owners are responsible to ensure their pets are not a nuisance or disturbance to other guests. Disturbances include, but are not limited to: constant barking, howling, running loose, and etc.
3. Pet waste must be picked up and disposed of in the dumpster.

BASE PONDS

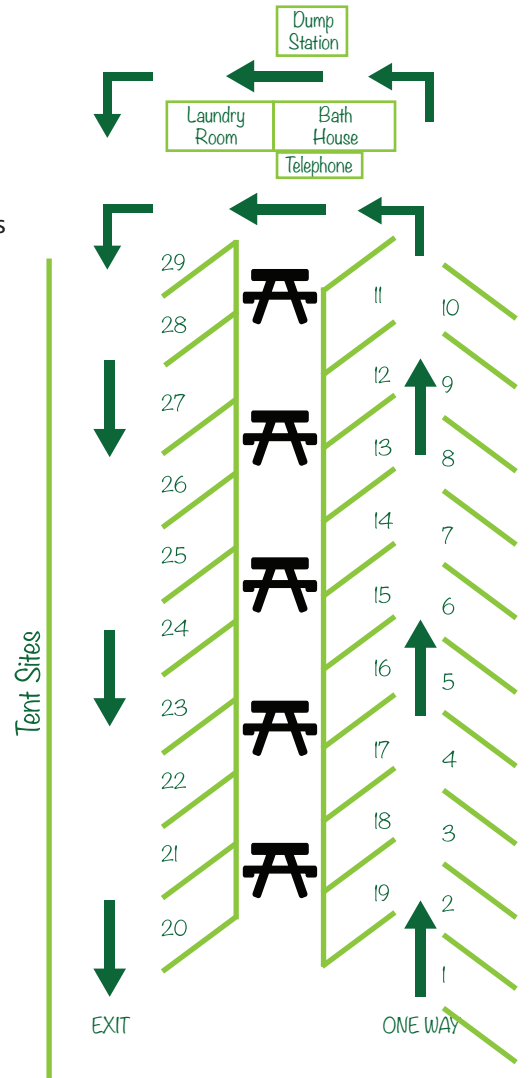


1. Fishing license and base fishing permit is required.
2. Swimming and wading are not permitted.
3. DO NOT feed the geese and ducks due to proximity of military aircraft.

FAM CAMP RULES

1. An airtight sewer connection or sewer donut is required on ALL sewer hookups.
2. Changing sites is NOT allowed.
3. Speed Limit is 5 mph.
4. All household trash goes in the dumpsters behind the bathhouse.
5. Please keep the site free of clutter, trash, and cigarette butts.
6. No driving or parking on grass.
7. Children 11 years old and under must be under adult supervision at all times.
8. Dog walking is around the pond. All pet waste must be picked up & placed in the dumpster.
9. Pets cannot be left outside when you leave the campground.
10. Quiet hours are 2200 - 0700.
11. RVs will be parked end to end in assigned spaces, not less than 6 feet between rigs. This is a fire/safety requirement.
12. Waste water is NOT permitted to be drained onto the ground. If you have a spill, do not spread it with water. Tell the office immediately.
13. Children must be supervised when in and around the bathhouse and laundry room.
14. No mats or carpets permitted on grass.
15. Reminder: hitching & unhitching of tow vehicles are behind the bathhouse.
